Hi Deb and all, Deb - not sure if you are in a position to read harm paras, but they look good to go from my perspective (the last sentence you wanted re-inserted has been done so). Also, re OA, I think the injunction should be as drafted currently by Counsel – to apply to all products not the narrower approach queried by Sharyn – see AGS response, and most practical relief should apply to all products, and can be justified etc.

So, I think we are there, but will await confirmation from all on this email that you are content with the form of the final docs. Jane, once we get that confirmation, then I understand we are to circulate the final set of docs and the RG advice to Cmrs (following Commission last week). Jane, I will ask you to take care of that when the time comes (hopefully very shortly if all in our team reply quickly). We can let Cmrs know that we are planning to file the docs late this afternoon, for issue of MR tomorrow if still suits media team etc.
